Lisnagarvey Hockey Club takes the protection of personal information very seriously and has recently updated their Privacy Policy to comply with new data protection regulations (known as GDPR) which came into effect on 25<sup>th</sup> May 2018. Lisnagarvey Hockey Club's full privacy policy can be viewed at [www.lisnagarveyhockey.com/privacy-policy](http://www.lisnagarveyhockey.com/privacy-policy) but a summary of the key points is set out below:

- Lisnagarvey need to process (which includes storing) personal data to enable the club to function properly, which includes operating all the services and activities that members expect it to operate.
- Examples of why Lisnagarvey needs to process personal data includes operating teams, running training sessions, entering teams into competitions and running social events.
- Lisnagarvey holds personal information which includes, names, addresses, contact details and other information required for operating its services. This may also include next of kin information.
- Lisnagarvey may hold sensitive medical data where required, for example to record accidents and injuries that occur.
- Lisnagarvey stores personal data securely and have put in place appropriate technical and organisational measures for this purpose.
- Personal data is stored only for so long as deemed appropriate for the purposes of operating as a hockey club.
- Lisnagarvey will only share your personal data where required to enable its services to operate, for example in the submission of player information to governing bodies or for the purposes of complying with competition rules.
- You have the right to request a copy of the personal data that Lisnagarvey holds.
